Given the region's vast population and the developing nature of its economies, South Asia presents an immense opportunity for higher education institutions. It is the second largest in terms of student enrolments and according to recent World Bank data accounts for 18% of all tertiary education students globally.

While the governments of these nations are involved in the development of primary education, the private sector dominates higher education. In India and Nepal, private education institutions, including universities, colleges, and stand-alone institutions, account for over 65% of higher education enrolment; in Bangladesh and Afghanistan, the share is over 40%; and in Pakistan and Sri Lanka, private HEIs cover 20% of all enrolment.

The top seven destination countries chosen by South Asian students are the USA, UK, Australia, Canada, New Zealand, Germany, and China, but new markets, such as Turkey and Ireland, are emerging as choices by students. The region has many opportunities, but it requires a dependable and knowledgeable local presence to manage agent, school, and university relationships to continually succeed in an increasingly competitive and everchanging environment

The year 2023 emerged as a vibrant period for the global higher education sector, with recruitment levels surpassing those observed before the pandemic for many Higher Education Institutions (HEIs).



A primer for HEIs looking to enter the market



South Asia Unlocked is a special series by T&A Consulting, serving as a primer for new market entrants as well as existing Higher Education Institutes (HEIs) looking to leverage opportunities in the vast South Asian market.

#### WINDS OF CHANGE?

#### Strict visa rules in top destination countries



For outbound students from South Asia, the top destination countries have traditionally been the US, the UK, Canada, and Australia. According the *Indian Students Mobility Report 2023*, which indicates entry numbers for 2022, the UK saw the highest year-on-year growth at 49.6% followed closely by Canada at 46.8%.

The US also had a significant growth of 18.9%. Australia saw relatively minimal growth of 0.7%. However, the recent updates to immigration policies in Canada, Australia, and the United Kingdom (UK) have sparked concern among students planning to study abroad.

These new rules, particularly regarding immigration fees, have especially caught the attention of those contemplating moving overseas for diverse purposes.

#### **Did You Know?**

Direct spending on study abroad by Indian students has been pegged at US\$47 billion for 2022. That figure includes tuition spending as well as housing and other living expenses, and it is projected to reach as high as US\$70 billion by 2025, based on current growth rates.





# REASONS DRIVING CHANGES IN IMMIGRATION POLICIES

Immigration regulations have seen tightening in the recent years for different reasons in different countries

#### Canada



Canada has been the leading country attracting students from the South Asian region. According to ICEF, in December 2022, there were around 320,000 Indian students with active study permits in Canada, making up 39.5% of Canada's total foreign enrolment.

The Indian student market for Canadian institutions has grown by 46% since 2019. It has been the primary choice for Indian students in three out of the last four years, with the US securing the top spot in 2021.

However, changes have come about in the past few months that affect the entry of international students to the country.

Among its various measures, Canada has announced a temporary, two-year cap on the number of new study permits issued to international students as part of the measures to tighten integrity controls within Canada's student visa programme.

The cap will be in effect for 2024 and 2025, and it is anticipated that it will result in a 35% reduction in the number of new study permits issued in 2024, compared to 2023. Additionally, Canada's Immigration, Refugees, and Citizenship Canada (IRCC) department has doubled the amount required to be shown by students in their accounts assuring they can sustain themselves in Canada.

This amount has now been increased from \$10,000 to \$20,635, making the financial requirements steep. In 2023, diplomatic relations soured between India and Canada, leading to an adverse impact on the Indian students' perception of how attractive a destination Canada is.

According to the latest data from IRCC, the number of Indian student permit applications finalized by Canada in the last quarter of 2023 dipped by nearly 42% when compared to October-December 2022.





#### Australia



Indian students helped drive the recovery of Australia's international education sector in the post-pandemic world. In January-August 2023, the number of Indian students in Australia were up 34% compared with the same timeframe in 2022.

The Australia-India Economic Cooperation and Trade Agreement (ECTA) signed in December 2022 aims to boost students' mobility between the two countries, with Indian graduates of Australian institutions permitted to remain in Australia to work for up to four years.

However, the Australian Government, in a bid to **overhaul its 'broken' immigration system** within the next two years, has declared its intention to decrease the annual visa intake. By June 2025, Australia plans to reduce the annual intake to 250,000 visas.

The revised strategy includes stricter visa regulations for both international students and skilled workers. International students would now be required to achieve higher scores on English exams.

The students applying for a graduate visa will require a score of 6.5 points, up from 6.0, while student visa applicants will need a 6.0, up from 5.5.

Additionally, there would be **increased scrutiny on their subsequent visa applications**, potentially extending their time abroad.

The revisions to student visas primarily target non-university institutions, some of which are colloquially referred to as 'ghost colleges' due to their reputation for offering little actual education, instead relying on their students to work in low-wage positions. But this will also impact incoming students.

While there are assurances that the commitments made under the ECTA will remain in force and continue to apply to Indian students in Australia, the student community is wary of choosing Australia as their preferred destination.





#### **United Kingdom**



By June 2023, the UK issued slightly under 500,000 study visas, with Indian students making up approximately 30%. The nearly 143,000 visas granted to Indian students signified a 54% increase compared to the previous year. However, in May 2023, in a move to curb growing immigration, the UK government announced that international students would be prevented from bringing dependants with them as of January 2024, except those enrolled in postgraduate research programs.

According to the 2023 Chartered Association of Business Schools (CABS) Annual Membership Survey, this will impact nearly half the business schools in the UK, as 44% of the country's business schools are reporting that they will miss their non-EU recruitment targets this year.

As per the report, "It is anticipated that enrolments for MBA programmes will be most affected as MBA students tend to be older and often wish to bring their family with them."

# Student preference changing as a response

Countries like Germany, Spain, France, Ireland, Dubai, Singapore, New Zealand, and Malta are becoming appealing options due to simplified visa procedures, greater access to information, and growing incomes. This trend is making international education more achievable for Indian students.

Indian students increasingly view Europe as an attractive option for education due to its combination of affordability and highquality academic offerings. Furthermore, Europe's strong industrial base adds to its appeal as a promising educational destination for these students.

France is actively embracing Indian students, with a goal of hosting 30,000 by 2030. Likewise, Germany's affordable tuition fees and outstanding education system have led to an impressive 107% rise in Indian students over the last four years.

Within three years, Spain has seen a surge of around 12% in its international student population. Meanwhile, in Singapore, the number of Indian students has increased from 1,500 to 10,000 between July 2021 and March 2022.


Ireland's international student population has tripled from 2010 to 2020, hosting over 25,000 students in 2021. Malta's English language training sector is rebounding, with a 103% increase in enrolments over 2021.





#### **COLLABORATION IN FOCUS**

#### Australia unveils first foreign university in India





Deakin University, Australia, officially unveiled its India campus in GIFT City, Gandhinagar in January 2024, making it the first university in the world to open an international teaching campus in India. This initiative marks a significant milestone, showcasing the partnership and dedication shared between the Indian and Australian Governments alongside Deakin University.

Prior to the inauguration event, Indian Prime Minister Shri Narendra Modi engaged in discussions with the Deakin delegation, focusing on bolstering collaboration between governmental and academic entities, reflecting on Deakin's longstanding three-decade presence in India, and looking forward to the forthcoming campus opening ceremony.

The university initiated the admission process for its two postgraduate programs—cyber security (professional) and business analytics—which will commence in July 2024 at its GIFT City campus. The university is offering these programs at an annual tuition fee of AUD 19,000, which is roughly half the cost of studying at the university's Australian campuses.

Furthermore, another Australian university—University of Wollongong—also plans to launch its GIFT City campus in July 2024, and will target scholarships for women in fintech. This aims to empower women pursuing careers in fintech and establish strong connections with companies and alumni within GIFT City.



#### **NEWS AND UPDATES**

## Australia releases Migration Strategy, tightens international student visa rules



In December 2023, Australia unveiled its Migration Strategy, ushering in alterations to student visas aimed at deterring non-genuine applicants. These reforms will impact the AUS\$30 billion-per-year international education sector. Changes involve reducing the post-study work visa by two years and reversing previously announced extensions, along with ending pandemic-era concessions like uncapped working hours.

This move addresses concerns about certain education providers, especially in the VET sector, aiding non-genuine students in entering Australia's job market through student visas. The new Genuine Student Test requires students to demonstrate that additional courses complement their degree. Despite these changes, Indian students remain eligible for longer post-study work visas due to provisions in the 2023 India-Australia free trade agreement.

#### IIT Guwahati signs MoUs with international universities

The Indian Institute of Technology, Guwahati has signed 4 MoUs with Dalhousie University, Canada, and Gifu University, Japan to enhance knowledge exchange. These partnerships were solidified during the 3-day event, the 'Japan-NER Bioeconomic Technology Cooperation Symposium 2024' (JNBTCS-2024), being hosted by IIT Guwahati from 3 – 5 March 2024.

# UGC to penalise EdTech companies offering unapproved online foreign courses

India's University Grants Commission (UGC) is to take action against EdTech companies offering foreign degree and diploma courses online without approval. In a public notice issued in December 2023, it mandated that no foreign higher educational institution shall offer any programme in India without the prior approval of the commission.

#### Taiwan introduces special scholarship for South Asian students

Taiwan has introduced a specialized scholarship program targeting students from South Asian countries. Known as the MOE Taiwan Scholarship Programme, this initiative offers undergraduate and postgraduate opportunities for aspiring scholars from nations including India, Bhutan, Bangladesh, Sri Lanka, Nepal and the Maldives. Eligible students to receive financial assistance ranging from 40,000-20,000 New Taiwanese Dollars.



#### Malaysia's Lincoln University College to set up campus in India



Malaysia's Lincoln University College has become the first foreign university to apply through the University Grants Commission's (UGC) dedicated application portal to set up a campus in India.

Lincoln University College is ranked in the 301-340th in the QS World University Rankings by Subject 2023.

The university is also placed in the 301–400th band in the Times Higher Education World Rankings.



#### Bangladesh's CSU and Australia's DIU enter MoU

In a step towards fostering international academic collaboration. Charles Sturt University of New South Wales, Australia, and Daffodil International University of Bangladesh have inked an MoU, part of which students from both universities will have the opportunity to engage in reciprocal visits, fostering cultural exchange and academic enriching experiences.



# DU most sustainable institute in India: QS Rankings 2024

The University of Delhi (DU) has been featured as the most sustainable Indian institute in the QS World University Rankinsgs: Sustainability 2024 released on December 5, 2023. Globally, the university has ranked at 220.

University of Toronto grabbed the top spot, followed by University of California, Berkeley and The University of Manchester, in the QS World University Ranking: Sustainability 2024 list.



# Kerala plans to open up for foreign universities

The Indian state of Kerala is now welcoming foreign universities to establish a presence in the state as announced by the Finance Minister K.N. Balagopal, during his Budget 2024 speech. The move is seen as an attempt to attract foreign investment in higher education while encouraging the state's youth to pursue higher studies Kerala. in Around 1.32 million Indian students went abroad in 2022. of which 4% were from Kerala.
